1. Understanding that as a participant in the V Commonwealth Youth Games in Samoa 3rd to 13th September 2015, I am participating in an event which has ongoing international and historical significance, and in consideration of the acceptance of my participation I agree that completion of this form and my continuing agreement to these conditions in all respects is a pre-condition of entry and eligibility for these Games.
2. I acknowledge and agree that the rules applicable to the Commonwealth Games also apply to the Commonwealth Youth Games and as such I agree to comply with the Constitution of the CGF currently in force, including any amendments made from time to time as available on the CGF website (www.thecgf.com). In particular, I agree to comply with the provisions of the CGF Constitution regarding the eligibility of competitors and rules relating to the identification on personal competition clothing and personal equipment. I also accept and agree to abide by the CGF's rules pertaining to Anti-Doping as detailed within the CGF's Anti-Doping Standard adopted for the 2015 Commonwealth Youth Games.
3. I also agree to comply with the CGF's Social Media & Digital Engagement Policy and agree not to participate in, support or promote betting related to the Commonwealth Youth Games.
4. I agree that my name, image and likeness may be identified, photographed, filmed, broadcast, published or otherwise recorded during the above period, in competition or any other events incidental to my participation in these Games, for the purposes now or hereafter authorised by the Commonwealth Games Federation ('CGF') in relation to the promotion of the Commonwealth Games, the Commonwealth Youth Games and the Commonwealth Games movement including for use to such effect by any third parties authorised by the CGF, including the Samoa 2015 Organising Committee.
5. I further agree that except as permitted by the CGF I will not allow my person, name, image or sports performances to be used for advertising purposes at or during the Commonwealth Youth Games. I further undertake not to perform any act or be involved in any situation that brings the Commonwealth Youth Games, the CGF, the Samoa 2015 Organising Committee or the official sponsors and partners of these Games and the Commonwealth Games movement into disrepute.
6. I agree that all photographs and moving images taken by me at the Samoa Commonwealth Youth Games, including those of athletes competing in any official venue or training during the above period, shall be used solely for personal use and non-commercial use and in accordance the CGF Social Media & Digital Engagement Policy for persons accredited at the Samoa 2015 Commonwealth Youth Games, unless prior written consent is obtained from the CGF.
7. I declare that I have full knowledge of all rules and regulations applicable to my participation in the V Commonwealth Youth Games, including those of the World Anti-Doping Agency and International Sports Federation, have been specifically brought to my attention by my Commonwealth Games Association (CGA) and/or my National Sports Federation and are specifically approved by me. I undertake to notify my CGA and/or my National Sports Federation immediately should there be any change to my personal information contemplated by this form which relates to my qualification for, attendance at, or participation in these Games.

8. In consideration of my entry and participation in these Games I agree that I participate in at my own risk. I undertake to take all reasonable measures to protect myself from the risks of participation. I agree that I am responsible for all property I bring to the Games sites and that the Samoan Government, the Samoa 2015 Organising Committee and the CGF accept no responsibility for any loss or damage to this property. I release the Samoan Government, the Samoa 2015 Organising Committee and the CGF (and their respective executive members, directors, officers, employees, volunteers, contractors or agents) from any liability for any loss, damage, personal injury, death, economic loss or consequential loss whether in tort, in contract, under statute or otherwise, for any default, failure or negligence (to the extent permitted by law) in relation to my participation in these Games. Where a term of this waiver and release contravenes the law of the relevant jurisdiction under which any legal action is brought it will not apply, however such terms are severable and do not invalidate the remaining terms.
9. I acknowledge and agree that my personal information and personal data (including unspent criminal convictions and other sensitive personal data) can be stored, used and disclosed by the Samoa 2015 Organising Committee and the CGF (i) in connection with the organisation, administration and staging of these Games and the Commonwealth Youth Games generally; (ii) for the purposes of carrying out background checks if required by the Samoan authorities and other relevant international authorities in order to gain accreditation and (iii) any other activities as contemplated in this entry form or to which I consent.
10. I agree that any dispute or differences relating to or arising from my participation in the Games shall be resolved by my CGA, the International Federation governing my sport, the Samoa 2015 Organising Committee and the CGF and if not so resolved shall be submitted to the CGF's Federation Court for resolution, subject to a right of appeal to the ad hoc division of the Court of Arbitration for Sport for final and binding arbitration. Except for disputes resolved under the CGF Constitution or by the CAS, the laws in force in England & Wales will apply to this agreement and I agree to submit to the exclusive jurisdiction of the Courts of England & Wales.
