## General

I understand that as a participant in the VI Commonwealth Youth Games to be held in the Bahamas in 2017 ('the Games'), I will be participating in an event that has ongoing international and historical significance. In consideration of my being accepted to participate in the Games, I agree that by completing this Form I agree to be bound by, and comply with, the conditions set out in this Form and understand that doing so is a pre-condition of entry and eligibility to participate in the Games.

## Use of image and marketing

I agree that my name, nickname (if any), assumed name (if any), image, voice, performance, signature and likeness ('the Images') may be photographed, filmed, broadcast, identified or otherwise captured or recorded during competition (or any other events incidental to my participation) in the Games. I give my unconditional and irrevocable consent to the Organising Committee of the Games, Bahamas 2017 Commonwealth Youth Games ('the OC'), the Commonwealth Games Federation ('the CGF') or anyone authorised by them to capture or record the Images during the Games and/or any other events incidental to my participation in the Games ('the Footage') and to copy, publish, broadcast, distribute and communicate the Footage in perpetuity to the public by any means, in any format and on any media or technology whether now existing or created in the future, as may be agreed by the OC and/or the CGF without payment to me. The Footage shall be the OC's exclusive property for the duration of the Games, and upon completion of the Games, the exclusive property of the CGF. I also release and discharge the OC and the CGF from all claims whatsoever including any claims relating to infringement of my moral rights in connection with the use of the Images in the Footage and my rights in them.

I also consent to, and license the use of, the Images in perpetuity for all other current or future purposes (both commercial and non-commercial) authorised by the OC and/or the CGF including marketing and promotional activities in connection with the Commonwealth Youth Games by the OC, the CGF and/or any commercial partners of the OC, the CGF and/or the Games from time to time.

I further agree that except as permitted by the OC and/or the CGF, I will not allow any person or entity at or during the Games to use my person or the Images for commercial, advertising, marketing or promotional purposes or in a way that suggests a person or entity has a sponsorship arrangement with the CGF, the OC and/or the Games at or during the Games. I further undertake not to perform any act or be involved in any situation that brings the Games, the CGF, the OC and/or the commercial partners of the Games, the CGF and/or the OC and the Commonwealth Games movement into disrepute or censure.

## **Gambling and fair play**

I agree not to participate or assist in any gambling or betting activities associated with the Games; specifically, I will not bet on myself, other participants from my CGA or any competitor or opponent (whether to win or lose), I will prevent members of my family or friends from doing so (so far as I am able), I will not share any performance information relating to competitors taking part in the Games with anybody, and I will never accept money or any benefit in return for influencing the outcome of any event at the Games.

I agree to abide by the principles of fair play and non-violence and to behave accordingly during the Games.

## **Compliance with the Constitution of the CGF and other rules**

I agree to comply with the CGF Constitution and rules of the CGF currently in force, including any amendments made from time to time as available on the CGF website ([www.cgf.com/entries](http://www.cgf.com/entries)). In particular, I agree to comply with the provisions of the CGF Constitution regarding the eligibility of competitors for the Commonwealth Youth Games and the rules relating to identification and branding on personal competition clothing and personal equipment. I also accept and agree to abide by the CGF's rules pertaining to anti-doping as detailed within the CGF Anti-Doping Standard adopted for the Games. I acknowledge that I have been provided with access to a copy of the CGF Anti-Doping Standard for the Games through my CGA. As a condition of my entry and participation in the Games I further agree to familiarise myself with and comply with the relevant provisions, rules, statutes and regulations of the OC, the CGF, the World Anti-Doping Code, my International Federation ('**the IF**'), my CGA and my National Federation ('**the NF**'). I undertake to notify my CGA and/or my NF immediately should there be any change to the information I have provided in this Form which relates to my qualification for, attendance at, or participation in the Games. I further agree to abide by any classification rules of my sport. I agree that I must complete any security and accreditation documentation in the form and by the date requested by the OC, and I must be eligible to receive and I must continue to hold accreditation from the OC during the Games. I agree to familiarise myself and comply with any rules of the Games, including any Games or Village Code of Conduct, the OC's accredited persons' social media policy and other Games policies as in force from time to time and provided to me by or on behalf of the OC. I acknowledge and agree that I will be held responsible to pay the total cost of damage I cause to any property (or the cost of replacement where property is lost) at the Games Village, competition venues or training venues (except in the case of competition and training venues where such damage is caused by reasonable wear and tear as a result of training for, or competing in, the Games). I agree that all photographs and moving images taken by me (or on my behalf) at the Games, including those of athletes competing within any Games venues, shall be used solely for personal and non-commercial purposes, unless prior written consent is obtained from the OC and/or the CGF.

## **Waiver and Release**

In consideration of my entry and participation in the Games, I agree that I participate in the Games at my own risk. I shall take all reasonable measures to protect myself and all other participants, officials and spectators from the risks of participating in the Games and undertaking other activities while at the Games. I agree that I am responsible for all property I bring to Games sites and that the OC, the Bahamas Government and the CGF accept no responsibility for any loss of or damage to this property. I release, the OC, the Bahamas Government and its respective agencies and the CGF (and their respective executive members, directors, officers, employees, volunteers, contractors or agents) from any liability for any loss, damage, personal injury or death suffered by me in relation to my participation in the Games and undertaking other activities during the Games. Nothing in this 'waiver and release' section limits or excludes liability for: (a) personal injury or death caused by negligence; (b) fraud; or (c) to the extent such limitation or exclusion is not permitted by applicable law, and such terms are severable and do not invalidate the remaining terms.

## **Collection and use of information**

I acknowledge and agree that my personal information and personal data (including information about criminal convictions and other sensitive personal data) can be stored, used and disclosed by the OC and the CGF: (i) in connection with the organisation, administration and staging of the Commonwealth Youth Games generally including but not limited to the carrying out of ongoing Commonwealth Youth Games activities, anti-doping or other disciplinary activities, security at the Games, competitions and results, carrying out of integrity activities and provision of services to participants and media; (ii) for the purposes of carrying out background checks by the Bahamas Government, the Police and other relevant Bahamas and international authorities in order to gain accreditation; and (iii) any other activities as contemplated in this Form or to which I consent.

## **Resolution of disputes**

I agree that this Form shall be governed by, and construed in accordance with, English law. I agree that any dispute or differences relating to this Form and/or arising from my participation in the Games, other than with respect to anti-doping matters where the CGF Anti-Doping Standard shall apply, shall be resolved between myself and my CGA, my IF, the OC or the CGF (as applicable) and if not so resolved shall, in accordance with the CGF's Constitution, be submitted to the CGF's Federation Court for resolution, subject to a right of appeal to the ad hoc division of the Court of Arbitration for Sport ('**the CAS**') for final and binding arbitration. In respect of any other contractual or non-contractual disputes, that are not resolved under the CGF Constitution or by the CAS, I agree to submit to the exclusive jurisdiction of the Courts of England & Wales.

## **Administration by the CGA**

I understand that my entry into the Games will be administered through the CGA and that the CGA shall determine whether or not I am selected to represent the CGA in the Games.

## **CGA Acknowledgement**

In signing this Form the CGA hereby consents to and approves all provisions of this Form (including the resolution of disputes clause) and guarantees that: (a) the relevant rules, including those referred to above, have been respected and brought to the attention of the participant; and (b) the participant forms part of the CGA's delegation. Where a parent/legal guardian has signed on behalf of a participant, the CGA certifies and confirms that the person signing the Acknowledgement of Consent is the lawful parent/legal guardian of the participant and acknowledges that the participant's Team Leader has accepted responsibility for the participant in the manner stated in the Acknowledgement of Consent.
